E-Commodity Bazaar electronic commodity marketplace has been created to increase the trade capacities of its members. With this portal, the important experience acquired by İzmir Commodity Exchange in the exchange of agricultural products for 125 years will be combined with technology.

The website serving under the domain name www.ecommoditybazaar.com allows member firms to display the goods they want to wholesale on the portal, and put the products they want to trade on auction and reverse auctions.

Running with a closed membership system, the portal is a significant meeting point for the companies that seek new markets or want to trade agricultural and food products.

The mission of E-Commodity Bazaar, which does not stand a guarantor for the trading transactions to be conducted by the members, is to enhance the trading of agricultural and food products at international level and bring its members together. Seeking no profit at all, the E-Commodity Bazaar does not take any commission or obtain any material gain from the auctions to be held.

Created to serve both in Turkish and English, the portal has been designed to function mainly in English. Different languages will also be added once the website improves in terms of transactions carried out through it.

Many other products related to agriculture and foodstuffs have also been planned to be added to the portal that has been originally designed for the wholesale of agricultural and food products.

E-Commodity Bazaar enables member firms to benefit from trade receivables insurance with favourable prices, through which they can query the commercial risk level of the counterparty firm that they want to do business with.

Offering the opportunity to trade with companies from all parts of the world, the portal also informs its members about the price movements of various commodities in different exchanges around the world with the information pages available on the portal.

In addition, the member firms are able to log in to portal services from mobile devices with iOS and Android applications.



Who can register to the system?



Firms producing agricultural products and foodstuff, and those operating in the trading of such products, which are members of İzmir Commodity Exchange and/or of the chambers, exchanges and professional organisations cooperating with İzmir Commodity Exchange can register to the system.

Firms that are members to any chambers, exchanges and professional organisations not cooperating with İzmir Commodity Exchange, and those that are not members to any chambers, exchanges and professional organisations can file an application for membership. However, the membership of such firms is decided upon by the website administrator.

How to become a member?

The "Sign-up" form that is available on the home page is completed in order to be a member to E-Commodity Bazaar. Once the request for membership has been confirmed by the website administrator, a confirmation e-mail is sent to your e-mail address.

Do I need to pay for membership and any transactions on the website?

No payment is requested for membership, product showcase or auctions.



What is a store?

A store is the section where the profile of the members is located. From the store of a member, it is possible to access to the information about his firm, showcase products and the auctions held by him.

What is a showcase product?

"Showcase products" is the section where the members display and offer for sale their products out of auctions. In this section, information and data about the products and their prices are indicated. Member firms can classify their products as "Product with Geographical Indication (GI)" and/or "Organic Product" if they want. These products that are gathered under the "Specific Markets" section are distinguished from other products with an icon positioned on their images.



How to add a showcase product?

A member can add showcase products by entering all mandatory information in the "Add Product" section in his own store page after logging into the system.

What is an auction?

It is an auction announced on public auction basis by a member from a starting price for any product that he wants to sell in a certain period of time.



What is a reverse auction?

It is an auction announced on Dutch auction basis by a member from a starting price for any product that he wants to purchase in a certain period of time.

How to announce an auction?

A member can announce an auction by filling the mandatory information required by the "Open an Auction" section in the control panel.



What does the "Upper Price Limit" mean in auctions?

The "Upper Price Limit" set for the auctions indicates the price, for which the auction holder member is ready to sell his products right away. It is not mandatory to set an "Upper Price Limit" in each and every auction. Any bid placed at the upper price limit in an auction does not mean that the member placing the bid will be awarded the contract.



What does the “Lowest Price Limit” mean in reverse auctions?

The “Lowest Price Limit” set for the reverse auctions indicates the price, for which the reverse auction holder member is ready to purchase the product in question right away. It is not mandatory to set a “Lowest Price Limit” in each and every auction. Any bid placed at the lowest price limit in an auction does not mean that the member placing the bid will be awarded the contract.

Can an announced auction be cancelled?

Any reverse auction or auction announced can be cancelled prior to the deadline for the bids provided that any offer is not bidden by any member.
